I am pleased to announce that Planners Network-Concordia has now become Planners Network-Montreal. The new PN-Montreal includes members from English-language universities, McGill and Concordia, and from francophone Université de Montréal. So far this year we have rotated meeting locations and have held a meeting at each university with about 12 regular members plus additional attendees that turn up at each school. We are planning several small events that will take place in each of the schools such as movie nights, an article club, and guest lectures as well as a Bicycle Fair for the spring 2006 to promote the use of cycling as a means of transportation in Montreal. On November 22nd, we had a guest lecture by Richard Bergeron, mayoral candidate for the independent party, Projét Montréal. Mr. Bergeron spoke to us about Projét Montréal's efforts to reduce sprawl and promote sustainability in the central city. The event was attended by over thirty people. We plan to promote PN-Montreal as a way to bring together the Montreal-area planning schools and the larger public.

Tending the Garden: From Grassroots to Green Roofs

Chicago is often considered the birthplace of organizing with the "radical" work of Saul Alinsky in Chicago's Back of the Yards neighborhood. While new models of organizing have developed since the 1930s, the idea that people should determine what happens in their community continues to be a driving force in progressive planning. Today, equity and participation underpin a wide range of projects-based aimed at attacking urban injustices including artists reclaiming public space; public housing residents fighting to keep their homes; families and kids trying to improve their schools; and disabled people pushing to get equal access. Equally important to the progressive agenda is finding sustainable solutions to problems. While primarily focused on our environment, the issue of sustainability cuts across all discussions whether it is economic, social or political. The theme of the 2006 Planners Network Conference in broad terms is

progressive planning and what it means today as we look to the future. How do we create equity that not only cuts across social barriers, but also across generations as well? As tenders of our own professional garden, it is ultimately up to us to decide.

The Planners Network Conference 2006 will bring together an array of planning practitioners, community and economic development professionals, organizers, policy analysts, students and faculty to explore the history and future of planning as a progressive profession. The conference will explore innovative strategies and successful models for changing public policy and shaping the planning profession to produce more equity. The conference will provide an important forum for linking academics, with community leaders and planning professionals, and exploring new opportunities to shape the planning profession.
