Call for articles for Progressive Planning

The Fall 2006 issue of Progressive Planning will focus on water politics and policies, internationally and in the United States. Marie Kennedy is editing this issue. Some issues that might be addressed are noted in the following:

Without water, civilization is impossible--and we're running out of it. As water becomes more scarce, competing needs for water—as a fundamental life support, an economic resource and a source of inspiration and spirituality—increasingly erupt into violence. The World Bank predicts that wars of the future will be about water. More than a billion people already lack access to fresh water and millions die every year from contaminated water or the lack of water—mostly in Africa and Asia. Meanwhile, water consumption is doubling every 20 years. Global corporations, the World Bank and some governments are pushing for the privatization of water systems, while grassroots organizations are fighting to prevent commodification of this vital natural resource. Where there is no convenient source, it is women who bear the burden of fetching heavy loads of water from great distances. Here at home, we take for granted the supply and purity of the water that flows from our taps--but for how long? Already, local communities face water bans in the summer, water rates are skyrocketing, and wells and aquifers throughout the country are being poisoned. Within the U.S., as elsewhere, struggles between agricultural, industrial and residential uses of water shape development for large regions of the country. In short, water is a “prism” through which we can understand a broad range of issues of inequality and power.

PN MEMBER UPDATES

Dr. Alejandro Rofman, our Argentinean PN member, was awarded last October with a **special decoration from the University of Buenos Aires**. He was appointed as Honorary Professor of the University, specifically at its School of Economics. This nomination will allow him to be the head of a team charged with carrying out a new graduate studies area of activity in the next year. The new graduate area will be related to the current and future development of Social Economy experiences. In addition to the two-year graduate degree curriculum the new Specialist in Social Economy area will include research on the structure of cooperative and self-organized organizations working on the basis of solidarity, non-profit objectives and full democratic managing of the different kind of institutions belonging to the Social Economy philosophy.

Assistant Professor Clara Irazábal, University of Southern California School of Policy, Planning, and Development, wrote the book: **City Making and Urban Governance in the Americas: Curitiba and Portland** (London: Ashgate, 2005). Curitiba in Brazil and Portland in the US are cities that have achieved recognition for exemplary urban planning programmes over the past three decades. As such, they provide particularly useful illustrations of the intense development pressures that many

urban areas currently face. This book explores the dynamics of their urban governance, arguing that, in general, there has been a unique synergy derived from the combination of visionary leadership, innovative urban plans and effective citizen involvement. The book argues that, while urban design and architecture are key to the success in making cities livable and in augmenting the global reputations, such sensitive, innovative urban planning and design projects first need to be governed effectively and grounded within the specifics of their local cultures and existing built environments.

From **David Driskell**:

UNESCO Chair for "Growing Up in Cities" launches at Cornell. The Growing Up in Cities project--with its roots in Kevin Lynch's work of the early 1970s--has entered a new phase with establishment of a UNESCO Chair in the Department of City and Regional Planning at Cornell. The global action research initiative engages young people in low income areas to conduct participatory evaluations of their communities, identify priorities for change from young people's perspective, and work with adult allies to make change happen. The project has been active in 16 countries and 50 sites over the past ten years. Current projects are underway in New York City, four Canadian cities, Guadalajara, Tokyo, Nairobi and Sao Paolo. The GUIC international network will be gathering at the World Urban Forum in Vancouver, June 2006. Plans are in development for a "Chair launch" this spring in NYC, as well as for an NYC youth forum led by young people from the Growing Up in NYC project. From **Kara Heffernan**:

The **Center for Neighborhood Technology's (CNT)** recently renovated office has been certified by the U.S. Green Building Council (USGBC), the entity that certifies sustainable buildings, as "Platinum." Platinum is the highest certification USGBC grants under its LEED (Leadership in Energy and Environmental Design) green building rating system, and CNT's building is only the thirteenth in the country to have received it. With this certification we hope to illustrate two important points about green building. First, creating a high performance green building does not require bottomless pockets and it does not require a new building. Retrofitting old buildings--as we did--offers great potential and is one important strategy for improving the sustainability of our cities. Second, green is not just good for the environment, it also pays economic rewards. Our building is about 52 percent more energy-efficient than a typical building designed to Chicago energy code (ASHRAE) standards, which should yield CNT ongoing economic benefits. Assistant professors in Environmental Planning/ Community Planning and Design/ Regional Policy and Governance

The **University of California, Davis** seeks applicants for a cluster hire of three new assistant professors in the tenure track, whose research and teaching will contribute to an emerging area of emphasis on community and regional planning. Candidates will have the unique opportunity to help shape the research agenda of the new Center for the Study of Regional Change, which will facilitate collaborative research addressing the social, economic, policy, environmental and planning opportunities and challenges associated with regional change, including changing land uses and development patterns, alternate approaches to community design, agricultural-urban interface conflicts, emerging trends in governance, shifting demographics, population pressures, natural resource sustainability, and auto-dependent urban sprawl.

. **Environmental Planning:** Candidate's research should focus on the relationship between the built and the natural environment. Possible areas of emphasis might include sustainable environmental systems as they relate to community planning and design (water, wastewater, solid waste, transportation, etc.), bioregional analysis and planning, environmental impact assessment, landscape, open-space and habitat conservation, urban ecology and/or the rural-urban interface. Position is in the Landscape Architecture Program.

. **Community Planning and Design:** Candidate's research should focus on the relationship between people and the design of the built environment. Possible areas of emphasis might include the relationship between demographics and development patterns, parks and open space, sense of community, "smart growth" alternatives and/or public health issues related to community planning and design. Position is in the Landscape Architecture Program.

. **Regional Policy and Governance:** Candidates should have expertise in analyzing the social and political dynamics associated with regional change. Research should focus on public policy and governance, possibly including both traditional entities and new forms of governance featuring collaboration between public, nonprofit, and private organizations. The specific policy focus might include: transportation, land use, housing, rural-urban interface, social services, workforce development, or policy evaluation. Position is in the Community Studies and Development Program.

A Ph.D in an appropriate discipline is required. Appointees will be required to teach graduate and undergraduate courses. These are nine-month positions, with eleven-month term appointments in the Agricultural Experiment Station to be offered and continued based on academic personnel review.
