The Planners Network is an association of professionals, activists, academics, and students involved in physical, social, economic, and environmental planning in urban and rural areas, who promote fundamental change in our political and economic system.

We believe that planning should be a tool for allocating resources and developing the environment to eliminate the great inequalities of wealth and power in our society, rather than to maintain and justify the status quo. We believe that planning should be used to assure adequate food, clothing, shelter, medical care, jobs, safe working conditions, and a healthful environment. We advocate public responsibility for meeting these needs, because the private market has proven incapable of doing so.

We oppose the economic structure of our society, which values profit and property rights over human rights and needs. This system perpetuates the inequalities of class, race, sex and age which distort human relationships and limit the potential for a decent quality of life. We advocate a shift in current national budgetary priorities to favor human services, social production and environmental protection over military and other nonproductive expenditures.

We seek to be an effective political and social force, working with other progressive organizations to inform public opinion and public policy and to provide assistance to those seeking to understand, control, and change the forces which affect their lives.

The Planners Network Newsletter is published six times a year as the principal means of communication among Network members. Annual financial contributions are voluntary, but we need funds for operating expenses. The Steering Committee has recommended the following amounts as minimums for Network members: \$15 for students and unemployed; graduated payments for the employed of \$25 plus \$1 for each \$1,000 earned above \$10,000.

Get 'Em While They're Young

The one book I remember in incredible detail from childhood is Mike Mulligan and His Steam Shovel. Perhaps it even has had an impact on what I have done in the planning field. And my two-and-a-half-year-old son adores The Little House, even crying at the sad parts. So I was delighted to come across this essay in a sister publication, and thank my wife, Amy Fine, for bringing it to my attention and suggesting we use it in PN.

Are preservationists born or made?

The question hits home because I am a rookie parent. And when I take my daughter Elizabeth on that pilgrimage to the old neighborhood, and find myself reduced to telling her about my favorite five-and-dime—now an exit ramp and Econo Lodge—I intend to pass on some enduring notions of just who the good guys are.

I've come up with a theory: Whether you belong to the posse that's intent on fending barbarians off the heritage, or whether you acquire a taste for the wrecking ball depends on whether you grow up with the books of Virginia Lee Burton.

Admittedly, Burton's titles—The Little House, Maybelle the Cable Car, Mike Mulligan and His Steam Shovel—lack the wide propaganda reach of, say, Quotations From Chairman Mao. But there is mischievous power in the work of this master children's author whose books have sold millions around the world since they were first published in the 1930s. In the preservationist's arsenal, Burton's books are an underused secret weapon.

In *The Little House*, Burton's main character is a building with a personality, a friend. The house is curious to explore the new city popping up around her. As day becomes night and the seasons cycle by, she gradually becomes surrounded by sky-

scrapers, freeways and elevated trains. Her field of daisies is destroyed; she can no longer admire the moon and stars. She is rescued only when she is removed from her foundation and trucked back to the countryside. In these few disarming pages, the historical experience of unchecked urbanization can be grasped by a sixyear-old.

Burton didn't stop there. In Maybelle the Cable Car, a smiling urban-transit vehicle joins forces with San Francisco's "Save the Cable Cars" committee to battle the city fathers who worship economic progress. Preservation values triumph, while the reader enjoys a child's-level lesson in cable-car mechanics.

Still anthropomorphic in Mike Mulligan and His Steam Shovel, Burton coupled her character Mike Mulligan with a steam shovel named Mary Anne. Their livelihood threatened by modern gasoline and electric shovels, they triumph by proving to the cheering people of Popperville that they can dig a cellar for the new

town hall in just a day. Mike and Mary Anne take a triumphant bow, charmingly unaware that they neglected to get the steam shovel out. A boy suggests that they covert Mary Anne to a furnace. Presto! The threat of unfamiliar technology and the worker's fear of obsolescence are resolved in a textbook example of adaptive use.

True, the triumph of old-time intimacy over the march of impersonal change may be a fantasy. But sometimes we must suspend a little disbelief to assure that preservationism gets into the bloodstream.

Burton won the Caldecott Medal for The Little House in 1943. She told interviewers that the goal of the book was to represent the sweep of social history in terms that a child could understand. When a critic commented Burton's message was that the further we move from nature and the simple life, the less happy we become, Burton didn't disagree. But nowhere in her engaging drawings or in the sweet, bedtime rhythms of her prose will you find even a hint of lecturing or preaching.

The secret of Burton's books is that they play on our emotions, returning us to that precious world of childhood, where objects and surroundings are extensions of loved ones. It is truly a cunning technique.

Ours is an age of steady progress. You see it in drive-through safari theme parks and in the forced-air leaf blowers that have invaded the suburbs. But no developer, no technology, can compete in a child's mind with a house who feels homesick.

The battle for young minds starts early. For the next child born in your neighborhood, why not send over, not an erector set, but a copy of *The Little House?* The beauty is that developers will think the book is harmless.

Conference Reports

☐ CHILD CARE: From PN Member Ann M. Cibulskis (2955 S. Elias Ct. #2, Chicago, IL 60608): Resources for Child Care Management sponsored a national conference, "Child Care at the Workplace," in Chicago, June 11-12. The focus was on on-site child care centers and their growing importance as an employee benefit.

Most existing workplace centers (approximately 1,500 across the country) seem to have come about because employers wanted to do good for their employees, or because developers of office/industrial parks found child care to be a suitable amenity for attracting businesses.

One major conclusion was that employers have a role to fill in providing child care benefits, but that government is necessary for providing quality care to low-income families.

Issues of quality of care, quality versus affordability, liability insurance, management, location, government regulation, and government-sponsored care were addressed.

□ BIKING ISSUES/ACTION: From Networker Rick Hyman (Box 1214, Santa Cruz, CA 95061): A few participants wore shorts or t-shirts to the 4th Biennial Pro-Bike 86 conference in Seattle, but jackets and ties were more prevalent.

This excellent conference was professional, punctual, well-organized and informative. I picked up some good ideas from the six (of 42 available) workshops I attended, and from the many handouts. Anyone interested in browsing through the materials should call me.

The main themes of the conference seemed to be to institutionalize bicycling concerns both on a general and specific project/program level, and to accomplish these activities in a reasoned, organized manner.

Some specific pointers:

- While controversy still exists over the safety, appropriateness and hence necessity of striped bike lanes, there is general agreement that (Class III) "Bike Route" signs are worthless by themselves; instead warning signs to motorists and/or directional signs to cyclists should be posted as appropriate.
- Bike maps can either show bike routes or show suitable cycling routes; in either case they should be clearly designed (using professional assistance) to show some key information. In some cases, maps are preferable to signs.
- Bicycle enforcement programs should concentrate on serious violations, and incorporate an educational component, including the involvement of parents of youthful offenders.
 - In determining appropriate bike routes, several factors
