Memphis in May!

The National Steering Committee of Planners Network is pleased to announce that Memphis, Tennessee will be the site of the 2011 Planners Network National Conference. The conference which is being hosted by the Graduate Division of City and Regional Planning at the University of Memphis will take place in the UM's newly -constructed University Center.

The conference will examine alternative strategies for building competitive regions that promote living wage employment and new business development. The first day of the conference, participants will have the opportunity to contribute to one of eighteen community-based planning and design charettes in communities in Tennessee, Mississippi, and Arkansas.

Conference participants will also have the opportunity to see the recentlycompleted, internationally-acclaimed, "I Am a Man!" documentary which tells the story of the 1968 sanitation workers strike that brought Dr. King to Memphis. On the cultural side, participants will have a chance to spend an evening listening and dancing to the best of American Soul music at the STAX Museum where such greats as Otis Redding, Isaac Hayes, Sam and Dave, Booker T. and the M.G.s helped create the Memphis Sound. Update from Lynne Elizabeth at New Village Press:

New Village Press title <u>What We See: Advancing the Observations of Jane Jacobs</u> was given 1) the **2010 Jane Jacobs Urban Communication Book Award** from the <u>Urban Communication Foundation</u> (see release attached), and 2) recognition as one of the top ten books in urban planning, design and development from *Planetizen*. *What We See* editors, Stephen Goldsmith and Lynne Elizabeth, and many of the contributing authors, including PN founder Chester Hartman, are Planners Network members.

Planetizen published its ninth annual list of the <u>ten best books in urban planning</u>, <u>design and development</u>. This year's selection includes the book *What We See*.

The *Planetizen* editorial staff reports that they based their 2011 list on "a number of criteria, including editorial reviews, popularity, *Planetizen* reader nominations, number of references, sales figures, recommendations from experts and the book's potential impact on the urban planning, development and design professions."

Their list includes short reviews of each title, including these closing sentences about *What We See*: "Perhaps the most compelling aspect of *What We See* is the way many of the contributors use the first person to explain what Jacobs has meant to them on a personal level in their relationships with particular urban environments and the other people they encounter within them. The tone is often reverential to the great urbanist, but also questioning. The essays brim with ideas and reflections about cities, their inhabitants and the vibrant neighborhoods that Jacobs loved so much."
