The **San Francisco Bay Area Chapter of the Planners Network** hosted Leaving the Postcard: A Disorientation Bus Tour of San Francisco on Sunday, March 20th during the APA conference. 50 participants jump aboard the outbound 19 Polk public bus line and journeyed through San Francisco's Russian Hill, Nob Hill, Tenderloin, Civic Center, South of Market, Potrero Hill, and Bayview/Hunter's Point neighborhoods. This reality tour of San Francisco included demographic, economic, historical information, and development pressures that revealed how a progressive lens can tell an alternative and often surprising story of these dynamic neighborhoods. The tour concluded in Hunter's Point with reflections by Supervisor Sophie Maxwell and Karen Pierce, President of the Bayview/Hunter's Point Community Advocates and coordinator of the San Francisco Health Department's Health and Environmental Assessment Task Force. #### From PNer Alex Schafran:

Letter from Porto Alegre – Report-Back From the 5<sup>th</sup> World Social Forum

When fellow PN Steering Committee member Josh Lerner mentioned to me in passing that he would be attending the WSF in Porto Alegre in January, as part of his lengthy sojourn south of the Rio Bravo, I realized that I too would be in the neighborhood and could join him in representing PN at the WSF. I was thrilled at the opportunity – relatively new to both Planning and PN, this seemed to be a perfect coming out party, one where grand connections would be forged and new ideas for progressive planning alliances would emerge.

As is often the case, great expectations lead to grand disappointments. Although the energy from the tens of thousands of participants, sunny and fantastically hot weather and infectious enthusiasm of our Brazilian hosts was invigorating, I quickly realized that Josh and my hopes of meeting an international array of progressive urbanists was not going to happen. Although we hosted our own session, participated in an INURA pre-forum conference, spoke fluent Spanish and a smattering of Portuguese, and spent hours scouring the two-inch think program for any sign of planning, the forum was simply too wide open, the days too hot, and the workshops to pedantic to really do the kind of networking that we has wanted to do.

But sitting in the hot sun and talking with the handful of planners and activists I did manage to meet, I was able to do a lot of thinking about what the forum meant for PN, and what role PN has outside of North America. Latin America is a particular passion and interest of mine, and I have struggled with the issue of how to incorporate Latin American issues into PN in a noncolonial way. Many of us are uncomfortable with the idea of "expanding" PN south – likewise, the few planners I met in Latin America, although they liked the idea of PN and were interested in connecting with other progressive planners in Latin America and the world, also were uncomfortable joining a North American group. Yet both of us realize that more and more the Americas are connected, whether it is through immigration (the US is now the second largest Spanish-speaking country in the world), the fight against the FTAA (hopefully), or simple globalization. The need for cross-border participatory planning has never been greater. So what can PN do in this context? Here are two recommendations:

**1. Start at home**. We should work to develop a **Spanish-language website**, and more importantly a **Spanish-language listserv**. This will enable participants south of the border to participate in discussions openly and freely without having to join a North American group. Work on building connections with Latino planners in the US and Canada.

**2. Use our conference** to promote understanding of these issues. **I propose hosting the 2006 conference in New Mexico** (I know Ted and Sean are excited), and having the focus be on border issues (not just US/Mexico but US/Canada, etc). Make a point of inviting Mexican planners, having bilingual (or tri-lingual) sessions. This is also an opportunity to reach out to the francophone community in Quebec.

## Update from PNer Alejandro Rofman, Argentina:

Alejandro Rofman, Ph D in Economics, has recently been appointed Honorary Professor at the University of Buenos Aires, Argentina. This appointment is offered to academic scholars with a long lasting teaching and researching activities in one of the schools of the University. Dr. Rofman is working as Full Professor at the University of Buenos Aires since 1972. His academic activity has been developed in the School of Economics. Last year, he was head of a research team encharged of designing a comprehensive plan for enhancing socio-economic performance of the small peasants in the poor rural lands of Argentina. The research was encharged by the Federal Secretary of Agriculture and it will be available in Spanish next May. ## **Obituary for Cushing N. Dolbeare:**

(Excerpts from the National Low-Income Housing Coalition Press Release)

Cushing N. Dolbeare died of cancer on March 17, 2005 at her home in Mitchellville, MD. She was 78. Cushing began the National Low Income Housing Coalition in 1974 when she organized the Ad Hoc Low Income Housing Coalition in response to the Nixon Administration's moratorium on federal housing programs. She served as NLIHC's Executive Director from 1977 to 1984 and again from 1993 to 1994. She remained active with NLIHC as a researcher, policy analyst, and board member until her death. Cushing was one of the nation's leading experts on federal housing policy and the housing circumstances of low income people. She designed the methodology for and was the original author of Out of Reach, NLIHC's widely cited annual report on the gap between housing costs and wages of low income people. She was also well-known for her work on analyzing federal housing subsidies, documenting the disparity between the cost of tax-based subsidies that benefit homeowners and direct spending on housing assistance for low income households. Senator Paul Sarbanes (D-MD) appointed Cushing to the Bipartisan Millennial Housing Commission, chartered by Congress in 2000 to examine and make recommendations to Congress on providing affordable housing for all Americans. In 2002, she was appointed Senior Scholar at the Joint Center for Housing Studies at Harvard University. At the time of her death, she was a member of the Board of Trustees of the Enterprise Foundation, and the Boards of Directors of the Housing Assistance Council, the Alliance for Healthy Homes, and the National Housing Conference. Cushing is survived by her husband of 49 years, Louis P. Dolbeare, their son Louis N. Dolbeare, their daughter Mary O'Kane, her sister Alice Lynd, and four grandchildren. #### Cal Poly Announces the 2005 Dale Prize!

The Department of Urban and Regional Planning at Cal Poly, Pomona has announced the winners of the 2005 William R. and June Dale Prize for Excellence in Urban Planning. The Dale Prize is awarded annually to recognize planning excellence and is the only planning award that creates dialogue between planning scholars and practitioners. The Dale Prize is organized around a focused planning theme each year. The theme for 2005 is *Voices in Planning: Transforming Land Use Practice through Community Engagement*, focusing on those planners whose work is giving voice to underrepresented communities, ensuring that land use planning and decision-making practices are responsive to these new voices, and creating a civic culture of community engagement.

The winner of the Practitioner Prize is Ms. **Ceola Davis**, Community Organizer, East St. Louis. Ms. Davis spearheaded the revitalization of East St. Louis and is widely recognized for uniting neighborhood residents around causes of unemployment, environmental degradation, and crime.

Two Scholar Prizes are being awarded this year. The recipients are:

Dr. Kenneth Reardon (PN Steering Committee Member), Associate Professor and Chair, Department of Planning, Cornell University. Dr. Reardon is the foremost academic engaged in community action research.

Dr. Leonie Sandercock, Professor, University of British Columbia. Dr. Sandercock is the preeminent theorist in this field and has influenced practice around the world.

Each of the winners will receive a \$5,000 prize and will be honored during a three-day visit to the Cal Poly Pomona campus. On April 14, 2005 the winners will participate in a colloquium on Voices in Planning. The event will be held on the Cal Poly Pomona campus from 4:00 - 6:00 pm. The event is free and open to all. Immediately following the Colloquium will be the awards banquet, which is open to all at a cost of

## **Rutgers University Offers Online Professional Development for Urban Planners**

The Edward J. Bloustein School of Planning and Public Policy, one of the top planning schools in the United States, is offering online professional development courses in land use law, leadership and management, and urban design and placemaking. Designed to meet the needs of busy professionals, Bloustein Online Continuing Education for Planners (BOCEP) will offer nine courses between April and September 2005. Each five-week course is taught at a graduate level by experts in the subject. Students can get to the course from any computer with an Internet connection, and participate at their convenience. There are no scheduled class meetings. Every class will provide ample opportunities for planners to discuss issues and resolve problems in collaboration.
