Seattle Chapter Started it Work

On October 21st and 23rd, graduate students from the University of Washington Urban Design & Planning Department held two informational and recruitment sessions in Gould Hall.

After a few months of development and conversations with local planning professionals, advocates, social and environmental justice groups, and local youth, a call to establish a chapter of the Planners Network for Seattle was deemed actionable.

The Seattle Chapter is currently engaged with a community capacity building exercise providing orientation to the planning process, citizen engagement expectations, and mitigation of redevelopment displacement and gentrification through more equitable mixed-income/mixed-use models.

The Seattle Chapter hopes to provide tools, information, and examples being developed in this region that may help improve planning and activate more in the related professions to consider broader public benefit and empowerment.
